

**Iluka Resources Limited- Balranald Mineral Sands Mine  
Monthly Particulate Monitoring (PM2.5 and PM10)**



The below air quality monitoring results have been obtained in accordance with the Balranald Mineral Sands Mine Air Quality Management Plan and assessed against the air quality criteria outlined in Table 4 of the NSW Development Consent SSD-5285.

The air quality performance for August 2025 was notably positive. Throughout the month, the monitoring station recorded zero (0) exceedance days in particulate levels, indicating consistent compliance with the air quality limits outlined in the above table.

Figure 1 and 2 represents the 24-hour average PM2.5 and PM10 performance in August 2025 respectively against the limits as mentioned in Table 4.

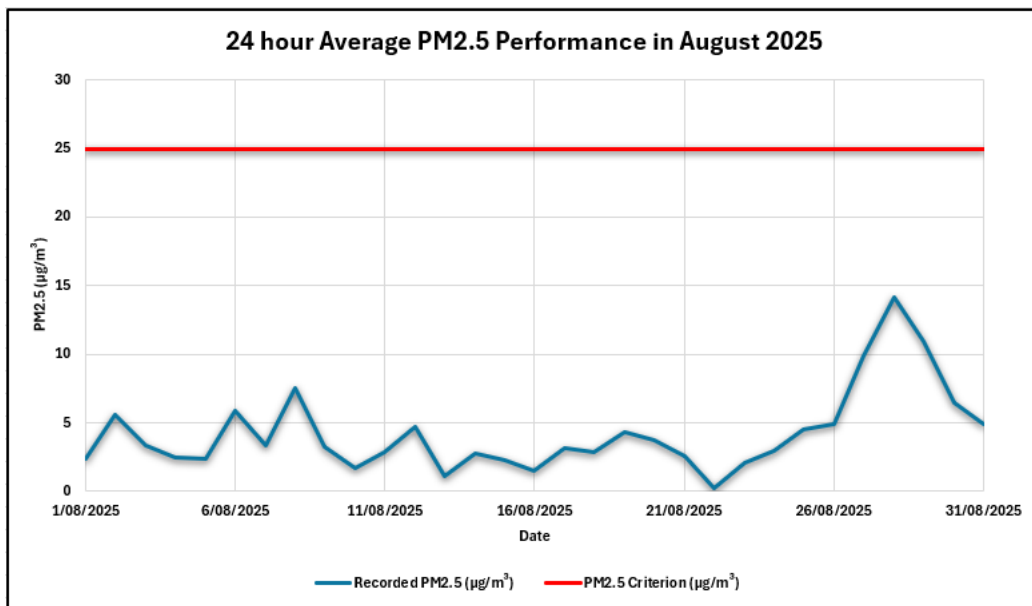

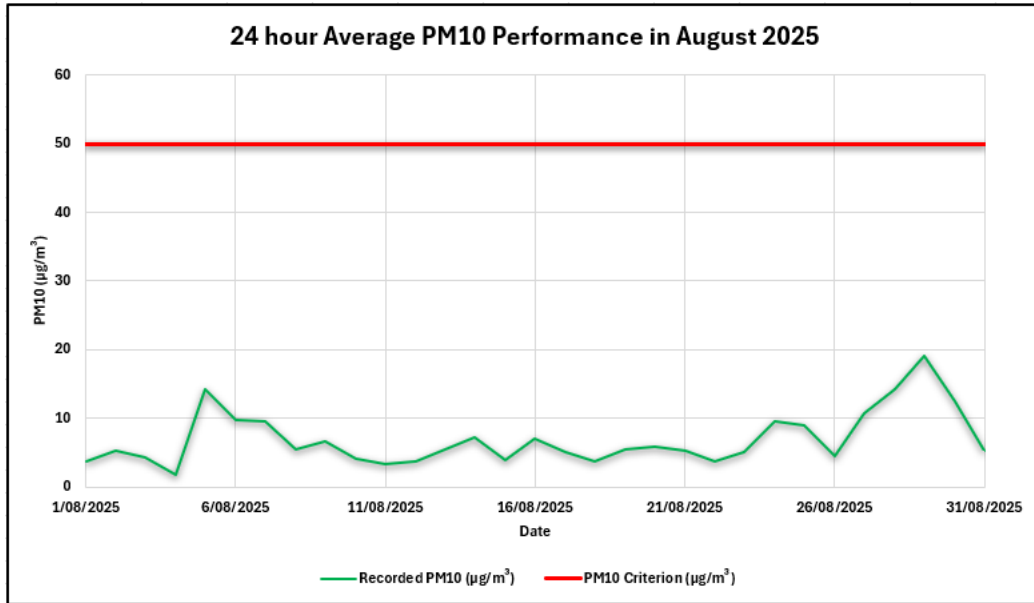
