Acute toxicity	Non toxic. There are no known hazards resulting from accidental ingestion of small amounts of ilmenite concentrate as may occur during normal handling. Ingestion of larger amounts may cause irritation to the gastro-intestinal system, mainly as a result of abrasion.
Skin	Not classified as a skin irritant. Contact may result in mechanical irritation.
Eye	Not classified as an eye irritant. Contact may result in mechanical irritation.
Sensitization	This product is not known to be a skin or respiratory sensitiser.
Mutagenicity	No evidence of mutagenic effects.

Radiation: Ilmenite concentrate contains low levels of naturally occurring radioactive elements of the uranium and thorium series. It has typical specific activities of 0.1 to 4.2 Bq/g (thorium-232) and 0.1 to 0.75 Bq/g (uranium-238). Low level gamma radiation from bulk or bagged stockpiles of ilmenite concentrate can increase gamma levels slightly above normal background.
