Mr Bastos is currently the Chief Operating Officer of MMG Limited since June 2011, with responsibility for all operations in three continents.

Mr Bastos has extensive experience in the development and operations of major projects (iron ore, gold, copper and nickel) and company management experience in the metals and mining industry in Americas, Australia, Asia and Africa.

This includes 28 years of international mining experience in the iron ore, gold, copper, nickel, and coal sectors, in the following positions:

- Chief Executive Officer of BHP Billiton Mitsubishi Alliance (BMA) from 2008 to 2011
- President of Nickel West of BHP Billiton Limited since January 2007 until 2008
